OneFifteen: A New Resource in Dayton

Many individuals who present to the Emergency Room with addiction have several complaints. However, the majority do not require admission to the hospital. Many of these individuals are treated in the ER and then sent back to the very environments and situations that lead to their addictions. Many return to the ER to be treated again for their

addiction, sometimes multiple times in a single day. The few hours they are in the ER is often not an adequate amount of time to start a meaningful conversation on how to get help. It is my experience that the resources in the communities in which I have practiced have been limited and are overwhelmed by the need in the community when it comes to addiction.

In 2017, 115 lives were lost each day to unintentional opioid overdoses in the United States. Health care providers were on the front line of this health care epidemic in Montgomery County, which was sadly deemed "Ground Zero" by many. Verily (a part of Google's Alphabet Company), Alexandria Real Estate Equities, Premier Health, and Kettering Health all partnered together as a community with a vision and opened OneFifteen in Dayton. As of today, OneFifteen has treated more than 3,300 patients. OneFifteen offers many treatment options to help individuals in all stages of their disease. First, it offers a Crisis Stabilization Unit, open 24/7 and capable of providing immediate care to individuals with addiction and withdrawal. If inpatient treatment is needed, OneFifteen Inpatient Residential Center provides 24/7 care and support until patients can transition to an outpatient care setting. It also offers an Outpatient Clinic where patients meet with physicians, therapists, and peer-support specialists, as well as participate in group therapy. Also, for those trying to rebuild their lives as they learn to live with addiction, OneFifteen Living provides a safe place for patients to live as they continue their outpatient treatment and look for their own residence. OneFifteen Living is within walking distance of the other sites and offers walking paths, exercise rooms, and meditation rooms. OneFifteen has also embraced technology and uses the OneFifteen Patient Companion App, which allows patients and caregivers to message, meet individually, or join a group virtually, and make and confirm appointments.

OneFifteen meets monthly with local Emergency Department leadership and Emergency Management Services at Premier Health

CompuNet Pfizer – BioNTech (Comirnaty) Vaccine Update





Immunocompromised Individuals:

At the end of August, CompuNet began offering a third Pfizer BioNTech vaccine dose at select patient service center locations in the Dayton area. The third dose was rolled out to accommodate individuals who are immunocompromised, based on Centers for Disease Control (CDC) criteria. Information about criteria to receive the third dose and appointment scheduling are available at **compunetlab.com**.

Expanded Days and New Location:

CompuNet has increased the number of Pfizer vaccine appointment slots to expand access for immunocompromised individuals seeking the Pfizer BioNTech third dose. In addition to patient service centers at Atrium Medical Center, Upper Valley Medical Center, Miami Valley Hospital North, Miami Valley Hospital Berry Building, and the Beavercreek Lakeview building, CompuNet opened appointments for the Pfizer COVID-19 vaccine at Miami Valley Hospital South on September 16.

Software Program Planned for TEG 5000 and TEG 6S Patient Results

Miami Valley Hospital and Atrium Medical Center are moving toward a new software program for the management of TEG 5000 and TEG 6S patient results. The new EPIC Citrix viewing program will be called TEG Manager.

The TEG Manager program allows for a consolidated area for Rapid TEG, Platelet Mapping, and other TEG results. In addition, it offers overlay and trending of patient TEG results over time and more graphics capability. Haemonetics College of TEG provides online web-based education on the TEG Manager (see instructions below). Once live with the new TEG Manager, you will use your personal EPIC network login to access the program, creating a more secure environment for patient results.

The projected go-live for the new TEG Manager will be sometime in November 2021.

Premier Health Launches Inaugural Orthopedics Externship for Minority High School Students

Premier Health and Premier Orthopedics have launched a high school orthopedic externship program to introduce students to the medical field at an early age.

Through a partnership with local school districts, the health system is connecting minority and female high school students with valuable orthopedics and sports medicine opportunities.



"Developing this program has been something I've always wanted to do," said **Michael Herbenick, MD**, a board-certified and fellowship-

trained orthopedic surgeon at Premier Orthopedics. "Patients want to be seen by someone who looks like them, talks like them, and acts like them. This program's goal is to bridge that gap and introduce more minorities and females to medicine."

The week-long program at Miami Valley Hospital South offered students hands-on experience through skill labs, including joint replacement; suture; sports medicine and arthroscopy; and bone sawing workshops. Students also participated in job shadowing opportunities with practicing physicians and surgeons at Premier Health.



"Providing mentors to teenagers interested in medicine is incredibly important," said **Louis Okafor, MD**, an orthopedic

surgeon at Premier Orthopedics at Miami Valley Hospital South. "I am proud our health system is helping the next generation by offering real-world experiences at a young age."

Students also had the opportunity to view orthopedic surgeries, giving them an upclose look at how surgical procedures are performed and how providers interact with their patients.




"The students said they had never been in a health care setting before," said Jennifer Jerele, MD, a board-certified orthopedic surgeon who is fellowship trained in orthopedic trauma care at Miami

Valley Hospital. "Providing this opportunity gave them the chance to see what takes place in a hospital, operating room, or doctor's office on a daily basis."

Students from Dayton Public Schools received internship credit hours for their participation in the externship program.

"There is no better feeling than getting to share your passion with someone and getting them excited about it as well," said Dr. Jerele.



Enhancement to EPIC Lab Orders Effective September 8

On Wednesday, September 8, the Premier Health EPIC team implemented a change to the EPIC system for clinicians when they place PSC (Patient Service Center) Hold orders. The EPIC enhancement allows the clinician to specify a future date for a lab order to be performed at a CompuNet Patient Service Center (PSC). The new, nonrequired "Date to be Collected" option is now available when placing a lab PSC Hold order.

The EPIC enhancement will provide CompuNet Patient Service Center staff with the patient's detailed collection date information when they arrive at the patient service center for lab work. This is especially beneficial when the provider orders multiple tests with different dates of collection on the lab order.

MEDICAL EXECUTIVE COMMITTEE UPDATE Surprise Billing Law Update

Beginning January 2022, two new laws will directly change the ability of out-ofnetwork hospital facilities and providers to balance bill patients in certain situations. The two laws are: the federal "End Surprise Billing Act" (effective January 1, 2022) and Ohio House Bill 388. regarding out-of-network care (effective

January 12, 2022). Together, these two laws effectively prohibit out-of-network hospital facilities (including the ER), freestanding ERs, physicians providing services at these facilities, ground and air ambulance services, lab services and ancillary services from balance billing patients unless a required notice and consent are obtained from the patient. Some of the important points to remember are as follows:


- Effectively these two laws together prohibit any balance billing for ER services, including post ER "stabilization care" as defined in the regulations;
- For an out-of-network facility or provider to balance bill a
 patient post-ER and post-ER stabilization care, the facility or
 provider must provide a required written notice and receive
 back a signed written consent to provide the care and balance
 bill the patient;
- The notice and consent must include an estimate of the balance bill for all services, including an estimate of what the patient's insurance might pay for the service;

- The notice and consent must be obtained at least 72 hours prior to the scheduled procedure or service, or, if scheduled in less than 72 hours, at least three (3) hours prior to the scheduled procedure or service;
- A positive aspect of both laws is that health plan insurers must pay out-of-network facilities and/or providers for care provided to their beneficiaries; the amount of the payment is primarily set by the new Ohio law, and the law also provides a process to arbitrate disputes regarding payment that is overseen by the Ohio Department of Insurance;
- Neither law applies to physicians in their private practice offices; and
- There is current lobbying at the federal and state level to either revise or delay proposed regulations.

It is important for providers and their business managers to work with their business and legal advisors to further learn the requirements of these two new laws and to prepare for this change. Some sources for additional information are:



Oncology Institute Focused on Access to Cancer Prevention, Clinical Trials and Specialized Treatment

We are excited to highlight some key programs and initiatives with our physician partners. Enhanced access to cancer prevention, clinical trials, and highly specialized cancer treatment for patients is top of mind for the Oncology Institute.

In 2020, the National Cancer Institute (NCI), along with others, raised concerns that the COVID-19 pandemic would delay diagnosis and treatment of some cancers. The American Cancer Society is urging providers across the country to increase access for preventive cancer screenings.

As an example of Premier Health's commitment to cancer prevention, the

organization is the flagship sponsor for the 2021 Making Strides against Breast Cancer event on October 16 at Island Metro Park with a rolling start. We would like to extend a big thank you to Marquita Turner, CNO/COO of Miami Valley Hospital South, who is this year's executive leader chair for the American Cancer Society.

Premier Health successfully launched a new cancer prevention program to identify and support patients who have an increased risk of specific types of cancer based on their family history or genetics. The best defense to cancer is to catch it early or prevent it. A new home-based fecal immunochemical test (FIT) for colorectal cancer is also now available at PPN Primary Care practices. While colonoscopies are the gold standard for detecting and diagnosing colorectal cancer, PolyMedCo FIT testing is another less invasive option for patients. PPN now has several primary care and gynecology practices across the entire Southwest Ohio region that offer patients access to a high-risk family assessment screening, genetic testing of 35+ cancers, and medical management of these identified risks.

Through August, Premier Physician Network had:

- More than 6,000 patients who completed their Hereditary Family Risk Assessment
- Genetic blood test ordered on more than 900 patients
- 7 percent have tested positive for a genetic mutation
- 35 percent have an increased risk based on family history
- 42 percent tested will need a change in medical management for cancer prevention
- Several patients have been referred on to a specialist, oncology specialist for closer management, preventive therapies, or prophylactic surgery.

The oncology service line also expanded clinical trials access for patients. We have successfully opened 10 new clinical trials and three more are pending this year. Furthermore, Premier Health is being assessed by MD Anderson Cancer Network to participate



and provide access to Phase II and III clinical trials. Premier Health has recently onboarded several new oncology specialists who are interested in clinical trials for their patients. 

ECMO Therapy enables critically ill heart and lung patients and their families to remain close to home. With ECMO, blood is pumped outside of the body to a heart-lung machine that removes carbon dioxide and sends oxygen-filled blood back to tissues in the body. Blood flows from the right side of the heart to the membrane oxygenator in the heart-lung machine, and then is rewarmed and sent back to the body. Miami Valley Hospital is the first in Dayton to offer this life saving therapy.
